Editor's Report - Siggi informed us the deadline for any Ads, Stories, etc. for the Newsletter will be the Friday following every Meeting.


Acitivities' Report - Ray said he will not be able to attend our next run and suggested a volunteerbe found to run the events.



as motorcyclists with helmets. Further, the death rate per unhelmeted rider is between $3\ \mathrm{and}\ 9$ times higher than for helmeted riders.

Second, the government considered the option of an intensive education program rather than safety helmet laws. Regrettably, experience has shown that education and advertising programs are not the complete answer. As you know, several years ago, the Manitoba Government embarked on an education campaign to encourage the use of seat belts. Despite the best efforts of that campaign, seat belt use in this province is still minimal and many Manitobans die annually in traffic accidents because they are not wearing their safety belts. Provinces such as Ontario and Newfoundland have had similar experiences with education programs.

Finally, the government considered the matter of freedom of choice. Freedom of choice has rarely been an issue of debate when it comes to a matter of safety. In workplace situations the use of safety equipment is mandatory. On a construction site all workers and, indeed, all visitors are required to wear safety helmets. No one on the site is given a choice of not wearing a helmet. Similar situations exist with firefighters, racing car drivers, x-ray technicians, miners, pilots and others. We believe that when it comes to safety on the highways, saving lives, not freedom of choice, should be the determining factor.

I know that you share with me the desire for safer highways in Manitoba. Designing safer highways, driver education, highway safety laws, seat belts, helmets and cracking down on the use of alcohol while driving will help us to achieve our goal of safer roads.

In Manitoba all citizens have the right to present their opinion on proposed legislation to the Law Amendments Committee of the Legislature. If you wish to present your views please call the office of the Clerk of the Legislative Assembly at 944-3636 for further details.

Again, I would like to thank you for bringing your views to my attention and I would like to thank you for the opportunity of presenting your government's position. I have enclosed for your information a booklet on motorcycle helmets which you may find of interest. Please note the U.S. DOT figures on Page 12 indicating a major drop in motorcycle fatalities on introduction of mandatory helmets and indicating a dramatic increase in fatalities following repeal of helmet laws in half of the states.

Dear Mr. Maunder:

Thank you for your letter outlining your views on the government's proposed legislation regarding the use of motorcycle safety helmets.

The government gave careful study to all of the issues surrounding the use of safety helmets prior to introduction of Bill 60 in the Legislature. I would like to outline for you some of the important considerations that led us to introduce this legislation.

First, the Government of Manitoba is committed to the health and well being of the citizens of this province. Statistical evidence from Canada and the United States shows beyond a shadow of a doubt that safety helmets ave lives. In good conscience the government cannot refuse to take an action that will save hundreds of lives in the next decade.

Manitoba is the only province in Canada that does not require motorcyclists to wear helmets. It is also the province with one of the highest motorcycle fatality rates (per 10,000 accidents). In fact, in comparison to our sister provinces of Alberta and Saskatchewan, - the two provinces with the most similar climate and road conditions - our fatality rate per 10,000 accidents is nearly twice as high. (Based on 1980 data)

As well, studies conducted before and after the introduction of safety helmet laws in the four largest provinces show a reduction in the casualty rate per 1,000 motorcycle registrations of between 8.3% - 32.4%. Manitoba studies indicate that helmets could have prevented a third of this province's motorcycle fatalities. In fact, motorcyclists without helmets involved in accidents suffer nearly twice as many head injuries

. I am sure that you are fully aware of the arguments, both pro and con, concerning the use of helmets and which have been debated at length many times in recent years.


The Government has, of course, given very careful consideration to this matter and equally to the right of choice of action of our citizens. However, the Government is also charged with the responsibility of making our highways as safe as possible for the user and reducing where possible the toll in human life and suffering that is occasioned to road users by way of motor vehicle accidents. This responsibility cannot, I suggest, be neglected even though the implementation of this new law may cause some inconvenience to the persons required to wear

The Bill still has to go before the Law Amendments Committee at which time the public can express its opinion. Should you wish to appear before that Committee, you should phone the Clerk of the House at
